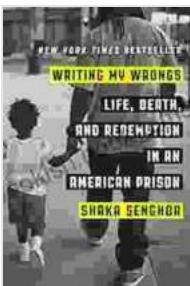


Life, Death, and Redemption in an American Prison

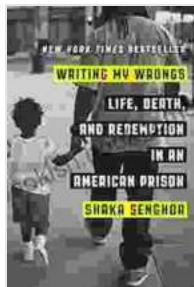

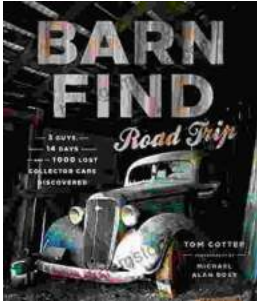

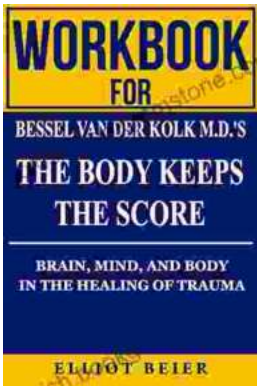
